The Ministry of Health has received funds from the World Bank towards the cost of implementing the Maternal, Child Health and Nutrition Improvement Project (MCHNP) in Ghana and intends to apply part of these funds to payments under contracts for the supply of Anthropometric Equipment for the above project.
2. The Ministry of Health invites sealed Tenders from eligible and qualified Suppliers for the supply of Anthropometric Equipment as listed in the Schedule of Requirements shown below.

Bidding will be conducted through **International Competitive Bidding (ICB)** procedures specified in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, January 2011 Revised July 2014 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest as well as provisions on matters pertaining to fraud and corruption as defined in paragraphs 1.14 and 1.16 of the Procurement Guidelines.

4. Bidders can quote for any number of lots. Evaluation would be conducted on lot-by-lot basis and Bidders must quote for the complete quantities per lot. Delivery requirements shall be within 120 days after the date of Contract signing. Bidders providing discounts should be on Lot by Lot basis and NOT cross-discounting over Lots.

A complete set of Bidding Documents in ENGLISH may be purchased by interested bidders on the submission of a written application to the address below and upon payment of a non-refundable fee of **Two Hundred Ghana Cedis (GH¢200) or Fifty United States Dollars (USD \$50.00)**. The method of payment shall be in cash.
7. Sealed Bids must be delivered to the address below on or before 10.00am on **Thursday 15th December, 2016**. All tenders must be accompanied by a **Bid Security (please refer to Table 1 under paragraph 2)** in US dollars or an equivalent amount in a freely convertible currency. Bid Security must be in the Form of a **Bank Guarantee or Insurance Bonds**. Bids submitted without Bid Securities would be rejected as non-responsive.
8. Late tenders will be rejected. Electronic bidding will not be permitted. Tenders will be opened publicly in the presence of the tenderers' representatives, who choose to attend at the address below at **10.00 AM on Thursday 15th December, 2016**.
