Guidelines"), and is open to all eligible as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest as well as provisions on matters pertaining to fraud and corruption as defined in paragraphs 1.14 and 1.16 of the Procurement Guidelines.
